The Business and Financial Planning Grant ("BFPG") is a Covid response intervention that can provide 80% grant assistance, up to £8k, to eligible businesses to engage a consultant to prepare a business plan to aid recovery due to adverse impacts caused by the Covid 19 pandemic. The scheme is targeted at micro, small and medium sized enterprises that are: • Existing Invest NI Client Businesses. This includes Entry, Tracked, Export Opportunity and Account Managed Customers • Potential Invest NI Client Businesses that meet the Invest NI qualifying criteria as outlined at investni.com*		The scheme is open to all existing and potential Invest NI Micro / SME Client companies and also Micro / SMEs within the Manufacturing sector. The scheme is not open to large businesses, the majority of which are not situated in rural areas. Given the nature of the programme, it is not envisaged that there will be a disproportionate impact on rural communities.

Applicants must be able to demonstrate that they have had at least 40% reduction in turnover for the quarter April-June 2020 in comparison to the quarter April-June 2019.

Consultancy process: in advance of applications opening a process will be undertaken to establish an approved list of consultants to undertake the work. The draft process for this is also attached.
