




- In 2025 there were 1,570 foreign owned businesses operating in Northern Ireland (defined as non-UK) which represents a 31% increase over the last five years.
- Almost half of all foreign owned businesses (45%) were from the Irish Republic (=420) and the United States (=285).
- Other key countries of ownership are Luxembourg (=65), France (=55), and the Germany (=40).
